MoU signed between NMIA and Ministry of Civil Aviation

NAVI MUMBAI: A Memorandum of Understanding (MoU) was signed between the Ministry of Civil Aviation and Navi Mumbai International Airport (NMIA) on the 11th April, 2018. This MoU was signed by Mr. R. N. Chaubey, Secretary, Ministry of Civil Aviation GoI and Mr. GVK Reddy, Chairman, Concessionaire, NMIA. Mr. Sumit Mullick, Chief Secretary, GoM was present at this occasion.

The International Competitive Bidding Process for selection of Concessionaire for development of Navi Mumbai International Airport on Public Private Partnership (PPP) basis was completed, with Mumbai International Airport Pvt. Ltd. (MIAL), as the selected bidder (Company presently operating Mumbai Airport at CSIA) and the same was approved by the State Cabinet, GoM. MIAL has incor-



porated a Special Purpose Vehicle (SPV) namely Navi Mumbai International Airport Pvt. Ltd. (NMIAL) as the Concessionaire and transferred 26% equity shares to CIDCO.

Concession Agreement (CA), State Government Support Agreement (SGSA) and Shareholders Agreement (SHA) with NMIAL were signed on 8th Jan. 2018, in the

presence of Hon'ble Chief Minister, GOM.

JNPT records highest ever traffic of 4.8 million TEUs

NAVI MUMBAI: JNPT, the premier container port in the country added yet another feather to its cap by clocking the highest volume of cargo handled with 4.8 million TEUs for the year ended March 31, 2018. The record

NSICT together handled 1.30 million TEUs and the newly opened BMCTPL accounted for 23,212 TEUs.

JNPT has been consistently improving its volume and turnover by implementing many trade friendly measures.



performance comes on the back of 4.5 million TEUs handled in the previous financial year. JNPT has been registering a continuous uptick in the traffic handled over the past few quarters and has registered 7.4 growth in container cargo volume during this financial year.

Total liquid cargo volume handled during this year stood at 7.18 million tonnes reflecting 5.98 percent growth over the last financial year.

JNPT has five container terminals and the break-up of container cargo indicated that Gateway Terminal handled 2.03 million TEUs, port-owned JNPCT handled 1.48 million TEUs, NSICT and

Several steps under ease of doing business and introduction of Direct Port Delivery (DPD) system have substantially contributed in saving of logistics cost and time for the trade. It is heartening to note that trade has started increasingly accepting DPD mode and its share has gone up to 39.15 percent. Rs 5 cr penalty imposed on Taloja MIDC CETP

NAVI MUMBAI: The NGT principal bench Delhi has directed the Taloja CETP Cooperative Society Lrd to deposit Rs 5 crore for its failure to contain pollution on Wednesday. Secondly companies have been directed to follow the norms strictly else action will be taken against them.

The three member bench comprising of judicial members Dr Jawad Rahim and SP Wangdi, and Dr Nagin Nanda while hearing the petition passed the order. The petition was transferred from western zone bench to its principal bench for lack of members.

The petitioner's counsel Adv Chetan Nagare said, "The bench was told by the Taloja CETP cooperative society lawyer that the CETP is dysfunctional since 2013. The furious bench then asked them to deposit Rs5cr to NGT in its interim order. The bench will then decide what to do with the money."

Adv Chetan Nagare added, "The bench also directed the CETP to furnish the repairing plan every ten day till



the next hearing. The NGT also asked the MPCB to check pollution and bring it under control. The NGT will hear the case in May 11, 2018."

The Taloja Industries Association president Satish Shetty said, "Now the industry cannot take pollution issue for granted with the NGT penalising the CETP. The money will be recovered from the CETP members ie industries. Even common

man can take industry in to action."

Adv Chetan Nagare said, "The final order may have huge penalty on the industry given the various pollution related complaints being heard by it."

The BSKP corporator Arvind Mhatre had dragged the Taloja Industries, CETP, MPCB besides state and union government departments to NGT for their failure to control pollution.

Google celebrated the 114th birth anniversary of singer-actor K.L. Saigal with a doodle. Hailed as the "Shehansha-e-mausiqi" or Sangeet Samrat (King of music), Kundan Lal Saigal recorded 185 songs, apart from acting in 36 films, in a span of about 15 years. He passed away in January, 1947. Kundan Lal Saigal appeared on the music map in the early 1930s when B.N. Sircar, the founder of New Theatres Calcutta, presented him to the Indian audience. He is considered to



be the first superstar of Indian cinema. His talent for both acting and singing was fully recognised after the success of Yahudi ki Ladki, a costume epic-based on Aga Hashr Kashmiri's famous play Misar Kumari with 19 songs including Saigal's ever popular Ghalib number "Nuktachin Hai Gham-e-Dil". It was around this time that Hindustan Records Company of Calcutta brought out

Saigal's famous recording "Jhulna Jhulao" which blazed a new trail in Indian music. Saigal attained stardom with the release of New Theatres' Chandidas in 1934. His outstanding and histrionic performance in P.C. Barua's masterpiece Devdas also got him wide appreciation.


Jyotiba Phule Jayanti celebrated at NMMC HQ

Opposition should be constructive – not destructive

Prime Minister Narendra Modi slammed the Opposition for putting roadblocks in the way of the government's development efforts. Modi's government has indeed been making a desperate effort to putting an end to the culture of keeping files pending, completing every mission, fulfilling every promise made to the people of the country etc. But why should he face destructive opposition? Banking goof up

In the recent spate of Bank frauds, the Industry is shaken up and there are changes expected in the Banking structure soon. Axis Bank CEO cuts short her tenure and it is an expected one. Again, ICICI Bank board is divided over continuing with Chanda Kochhar in view of allegation of impropriety. This is a very bad sign as some more drastic changes are on the cards. The ground rules of Banking were not followed and the top level executives are now answerable and there is no proper answer as everything took place in front of their nose during their peak period. Now they are repenting and trying to come out of the rut without any serious trouble. These moves come out amid controversy surroundings in their tenure and in the wake of the mounting NPA in these Banks.

The allegations of nepotism against Kochhar have put a question mark on the Bank's corporate governance. The rating agencies fear the ongoing investigations will undermine investor confidence in the bank and have potential implications for funding costs and liquidity. The major reason for such a setback for the top post holders is that they were retained as CEO for unduly longer period and that provided scope for major irregularities in these two major Banks. If Chanda is on a sticky wicket then Shikha Sharma is on her way out of her own. Banking goof up is a major setback in handling of these banks by RBI.

This means that Sharma's term has been cut down significantly and the lender will have to begin looking for her successor. Shikha Sharma took charge as the Axis Bank chief in 2009. Her tenure has seen Axis Bank go through a period of high growth, but recently, the lender has come under a cloud over the rising level of its non-performing assets. Last month, the RBI had imposed a ₹ 3 crore penalty on the bank for violating NPA classification norms.

The loan to Videocon group became NPA. As the amount involved is very large the RBI should step in and hold a high level enquiry and find out the reasons and fix accountability on the consortium of Banks. The decision of the RBI to withhold the bonuses payable should be praiseworthy. Similar steps in respect of PSU banks should be taken.

The ongoing crisis in India's banking system is finally at the doors of India's top private banks and is now threatening to sully the reputation of two of India's best known women bankers. ICICI Bank's managing director and CEO, Chanda Kochhar has been accused of being complicit in a quid pro quo arrangement that ensured investment in her husband's firm in lieu of bank loans to the Videocon group, while the Reserve Bank of India has raised questions over Axis Bank's chief executive Shikha Sharma's performance, putting her continuance in office in doubt.

Power corrupts and absolute power corrupts absolutely is true as far as Banking sector is concerned. Retaining Chanda Kochhar and Shikha Sharma for an unduly long time as CEOs of ICICI Bank and Axis Bank respectively is the root cause for all the problems in these Banks. RBI's checks and balances were not up to the mark on this count.

School students allegedly kidnapped and released

NAVI MUMBAI: A school principal and bus driver in Neral were booked for kidnapping few students. The LAES English High school bus driver had taken the students to his house after the final exam was over and locked them for two hours due non-payment of school bus travelling charges. The driver has allegedly threatened them. The Neral police has booked them under IPC sec 363, 342, 506 & 34.

The Neral police assistant inspector Somnath Jadhav said, "Around a dozen of students of LAES English High School were driven to the house of the bus owner Ramdas Ghodvinde (50) at Talvade village. Their parents were asked to pay the bus fees to take their child back. The students were allegedly made hostage by locking them in a room

between 11.30am and 2.30pm on Tuesday. One Gulzar Patel had lodged the complaint."

The Neral police has booked the school bus owner Ramdas Ghodvinde and LAES English High School Ajitha Nair under IPC sec 363 (kidnapping), 342 (wrongful confinement), 506 (criminal intimidation) & 34 (acts done by several persons for furtherance of common intention). The bus owner has not been arrested but the police quizzed the school principal.

The complainant Gulzar Patel's daughter Mahek Patel, class VII student was allegedly abducted. The incidence reported after their final examination was over. Gulzar Patel alleged, "I received a call demanding school bus fees payment to get my daughter back from the driver. Upon checking the school principal did not respond properly. We had paid all dues but

received no notice on any pending dues. My daughter was taken to Talvade village and was threatened."

The LAES English High School Principal Ajitha Nair said, "The parents had hired the bus and pay them. Whatever has been done by the bus staff is absolutely wrong and disturbing. But we came to know that around 25 students had gone for a party after their examination was over with their parents informed."

The school bus owner Ramdas Ghodvinde said, "The 25 students had a party after their examination. They had contributed for the same besides I arranged Vadapav for them from my pocket. I knew Gulzar Patel for years and had jokingly said to pay the bus fees to take back his daughter. But he lodged the police complaint. I have been operating the bus for years."
